ORDINANCE OF THE TOWNSHIP OF MONROE
AMENDING CHAPTER 131 OF THE CODE OF THE TOWNSHIP OF MONROE
ENTITLED "AFFORDABLE HOUSING"

BE IT ORDAINED a recommendation of an Amendment to Chapter 131 entitled "Affordable Housing" of the Code of the Township of Monroe was made to the Township Council by the Monroe Township Affordable Housing Board, memorialized on July 24, 2019 by resolution attached hereto as Exhibit "A".

BE IT FURTHER ORDAINED by the Township Council of the Township of Monroe, in the County of Middlesex, New Jersey as follows:

Section 1. Chapter 131- of the Code of the Township of Monroe, entitled "Affordable Housing" shall be amended to add § *131-6.F* as follows:

§ 131-6. Screening and Qualifications of Prospective Purchasers and Tenants.

[NEW] F. Municipally Sponsored 100% Affordable Veterans Housing.

In accordance with the Court approved Housing Element and Fair Share Plan dated June 2016, Monroe Township will undertake a municipally sponsored 100% affordable housing development on Lot 14 in Block 41, consisting of 37 rental units exclusively for Veterans and Veterans families, of which 6 units (15%) will be for very low-income households.

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 3. If any section, paragraph, subsection, clause or provisions of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged, and the remainder of the Ordinance shall be deemed valid and effective.

Section 4. This Ordinance shall take effect upon final passage and publication as provided by law.






