PERDIEM-EMT APPLICATION GUIDELINES

Thank you for your interest in applying for a position with Monroe Township Municipal Ambulance Service. The following list will aid you in completing the application process and outline the steps for the interviews. <u>ALL documents are required for admission</u> into the process and our agency will conduct background/reference checks, pre-employment drug screen and motor vehicle record check. As a reminder, **ALL** applicants **must** reside in New Jersey, unless otherwise exempted by law.

Step 1:

Submit completed application packet (obtained from the Office of Health & Human Resources or EMS) and <u>return to: *Office of Health & Human Resources*</u>. All applications with the required certifications **must** be sent to the Office of Health and Human Resources, **not EMS**.

Consisting of:

- Application for Employment (4 pages)
- Disclosure of Family Relationships Form (1 page)

Additional documentation required (**provide copies of all current documents to be submitted with application**):

- Resume (Prefer EMT Certification for <u>2 years & 2 years 9-1-1 experience</u>)
- o Valid NJ automobile driver's license
- o Graduation from High School, Vocational School or equivalent
- CPR card (acceptable NJ DOH-OEMS course)
- NJ EMT card (EMT B or EMT P)
- o DDC (Required prior to driving)
- CEVO (Required prior to driving)
- Hazmat awareness
- Hazmat operations (preferred)
- o ICS-100 & 200 level certificates
- FEMA/ICS I-700 & I-800
- o Developmental Disabilities

Step 2:

After we have received all the above information, you will be contacted for a Clinical Evaluation. Clinical Evaluation consist of written exam and hands on assessment scenario.

Step 3:

Upon successful completion of the Clinical Evaluation, you will then be scheduled for a comprehensive interview. If qualified, a recommendation to hire will be submitted and a conditional offer letter of employment will be given, which will entail a criminal background/reference check, pre-employment drug screen and motor vehicle record check.

Step 4:

Upon successful completion of your Clinical Evaluation, criminal background check/reference check, pre-employment drug screen and motor vehicle record check, you will be scheduled for at least four (4) orientation shifts (**Day Shift Only**). Upon successful completion of all four (4) orientation shifts, you will be able to submit your availability of hours to the EMS Director.
